DESCRIPTION OF INCIDENT:

On 11/25/13 at 1917 Hours KCSD and Dutton Fire were dispatched to a One Vehicle vs Tree Accident in the 4100 Block of 100th St. SE between Patterson Ave. SE and East Paris Ave. SE. The pickup was Westbound on 100th St. SE. The driver lost control of the pickup on the Ice covered roadway. The pickup left the South side of the roadway, striking a tree.
