DESCRIPTION OF INCIDENT:

On 12/24/13 at 1913 Hours the Kent County Sheriff's Department responded to a One Car Rollover Accident with an Ejection. The accident occurred on EB 84th St. SE, East of Cherry Valley Ave. SE. The driver lost control of his SUV and went of the roadway. The vehicle rolled multiple times before coming to a rest in the WB lanes of 84th. The driver, who was the only occupant, was not wearing his seatbelt and was ejected from the vehicle.
